## Wildwood West Road Association Board meeting Feb.10, 2016

Chairman Bill Croker called the meeting to order at 5:00 p.m. Members present were: Jim Burton, Bonnie Calkins, Bill Croker, Judy Parks, and Mark Rockwell.

Secretary's minutes of the previous meeting were approved. M/S/C (Burton/Croker) to approve minutes of the Dec.9 meeting.

Treasurer's report as of Dec.31, 2015 was approved. Balances in accounts: Checking (\$13,861.59), CD#1 (\$16,279.22), and CD#2 (\$10,128.01). Income from Aug.-Dec. 2015: interest earned (\$20.43). Expenses Aug.-Dec. 2015: PO box renewal (\$38.00), HP Stream-13 laptop for treasurer (\$282.20); and QB software (\$199.95). Three properties are still in arrears. CD#1 renewed on 12/27/14 @3%; maturity date 6/27/16. CD#2 renewed on 10/5/15 at 3%; maturity date 4/5/17.

## **Old Business:**

- 1) **Road maintenance**: Jim Burton reported that he had checked culverts and all look clear. He planned a road workday for **Saturday, April 9, 2016**. Volunteer workers should meet at Jim's house at 9 A.M. to move gravel, cut up two trees, and apply reflectors.
- 2) **Road sale**: Mark Rockwell led the discussion surrounding the road sale. Since our typical date is the same as LWW North Gate, and this year that is the weekend of our general membership meeting, the decision was made by the board to table this item until April 30. At that time the membership can decide if they want to have a sale this year, and if so, the Vice Chairman can plan it for early fall.

April 30: Annual general membership meeting; ballots will be counted for new officers and proposed bylaw revisions.

M/S/C (Croker/Calkins) By Feb. 13, the Board will submit the proposed bylaw changes to the members for review and comments; comments will be due by March 9, 2016.

4) Annual general membership meeting: 3 P.M., April 30 at Keith and Gigi Calkins' (20564). Association will provide and Gigi will prepare the main dishes and some drinks (water, lemonade, tea, and coffee); side dishes and other drinks will be provided by the membership.
