Meeting called to order at 3:45 PM with opening remarks from the Chairman, Steve Zoch. Thanked Al and Donna Gebhart for hosting and welcomed everyone who took time out of their busy schedules to attend allowing us to meet our quorum. Spoke about our amazing community and some of the history that has makes our road association special. At this time it is important that we address the Davis Sterling Act, passed by the California legislature, which is trying to pass on restrictions to all housing developments and associations. During the last several months the board has been consulting with our attorney, Allen Haley, to define our status as it applies to this legislation. It has become clear that we do not fall under this act, if we did could be very costly and restrictive. Our attorney advised the association to amend certain areas in the Bylaws, that has been done and the Amended Bylaws will be sent to all the members to vote on.

#### Treasures Report-Bob Spier

Bank balance \$12,918.43 as of 4/30/22. Fiscal Year 2022 no major road expenses, taxes that needed to be paid \$1,645. Fiscal Year 2021 legal fees \$4,000 and taxes paid \$2,551.14. if you want a copy of the full report, please contact Bob Spier. Annual road dues invoices will be mailed and total amount expected, as in years past, \$9,540.

#### Road Director Report-Jesse Ettlin.

The road is in good condition, no repairs scheduled currently. Met with contractors last fall for projected work, since those numbers are no longer current, will start the process of getting new bids for future projects.

### Chairmans Report-Steve Zoch

Packages for the Amended Bylaws will be going out, it is the <u>final draft</u> for you to vote on. Understandably there is a lot of information, if you have any questions, please contact me. The goal is to have full transparency. It has taken the board several months to draft the new Bylaws, with feedback from parcel holders attending the board meetings. All documentation for the corporation and supporting attachments, such as the 1976 Road Maintenance Agreement will clarify that that we do not currently fall under the Davis

Sterling Act. Some changes in the new version of the Bylaws: The board will have limits for expenditures unrelated to road maintenance, such as legal fees. No longer two classes of voters (burdened vs unburdened). A quorum for the annual meeting more clearly defined, 25% means 12 out of 46 members of the association present to conduct business. Please participate in the process of voting, it takes 2/3 of the membership in order to pass the Amended Bylaws.
