In response to the one area that is proving to be "sticky" (near 19941 Wildwood Drive) it was a known possibility in September, when the paving work was done in several spots on the road, that this could become an issue because it was already a soft spot according to the company doing the work. A possible solution to dig out the area and repave, the other areas are holding.

In response to addressing culverts on private property would need permission and a request for assistance by the parcel owner to do any work, not the responsibility of the association.
